


ESTABLISHMENT OF CHILD COURTS AT DISTRICT MALIR AND DISTRICT EAST KARACHI



(ON 24 - 25 FEBRUARY 2021)





Following the decision of the National Judicial Policy Making Committee (NJPMC) back in 2019 to establish model courts for women and children in each district of Pakistan, SJA and GDP have worked closely with the state actors to provide technical and financial assistance for establishing child courts.

With an aim to take the criminal justice reform agenda forward, two child courts have been established in the District Malir and District East, Karachi. It was a part of a chain of efforts to establish child courts in the province aimed at providing expeditious, child-sensitive and fair justice to children in contact or in conflict with the law as envisaged in the Juvenile Justice System Act, 2018, and other relevant child protection laws and the Constitution.

Sindh Judicial Academy and Group Development Pakistan (GDP) worked in collaboration and made persistent efforts for early establishment of the Child Courts. The High Court of Sindh transformed the physical spaces to make a child-friendly and conducive environment for the children visiting the courts.

The juvenile courts have also been equipped with toys and books to create a relaxing environment for kids to help them deal with the mental pressure and trauma of court visits.

Further to share, SJA and GDP arranged 03, Three-day training programs for Judges on "Laws Relating to Children and their Implementation Mechanism in Pakistan".
