# THE GENERAL CLAUSES ACT, 1897

<sup>1</sup>Act No. X OF 1897

[11th March, 1897]

*An Act to consolidate and extend the General Clauses Acts, 1868 and 1887.*

WHEREAS it is expedient to consolidate and extend the General Clauses Acts, 1868 (I of 1868) and 1887 (I of 1887); it is hereby enacted as follows: —

## PRELIMINARY

1. **Short title.** — (1) This Act may be called the General Clauses Act, 1897;

## GENERAL DEFINITIONS

3. **Definitions.** In this Act, and in all <sup>3</sup>[Central Acts] and Regulations made the commencement of this Act, unless there is anything repugnant in the subject or context,—

(1) **“Abet.”** “abet”, with its grammatical variations and cognate expressions, shall have the same meaning as in the Pakistan Penal Code (Act XLV of 1860).

(2) **“Act.”** “act”, used with reference to an offence or a civil wrong, shall include a series of acts, and words which refer to acts done extend also to illegal omissions:

(3) **“Affidavit.”** “affidavit” shall include affirmation and declaration in the case of persons by law allowed to affirm or declare instead of swearing:

This Act has been declared to be in force in Baluchistan by the British Baluchistan Laws Regulation, 1913 (2 of 1913).

It has been applied to Phulera in the Excluded Area of Upper Tanawal to the extent the Act is applicable in the N.W.F.P., subject to certain modifications; and also extended to the Excluded Area of Upper Tanawal (N.W.F.P.) other than Phulera with effect from such date and subject to such modifications as may be notified, see N.W.F.P. (Upper Tanawal) (Excluded Area) Laws Regulation, 1950.

It has also been extended to the Leased Areas of Baluchistan, see the Leased Areas (Laws) Order, 1950 (G.G.O.3 of 1950); and applied in the Federated Areas of Baluchistan, see Gazette of India, 1937, Pt. I, p. 1499.

The Act has been extended to the whole of Pakistan and shall be deemed to have been so extended on the 14th day of October, 1955, see the Central Laws (Statute Reform) Ordinance, 1960 (21 of 1960), s. 3 and Second Sch.

The provisions of this Act have been extended to the Special Areas of West Pakistan by West Pakistan Regulation No.1 of 1961 (*with effect. from the 13th September, 1961*).

(3c) “Baluchistan.” “Baluchistan” shall mean the territories comprised in the Chief Commissioner's Province of Baluchistan immediately before the fourteenth day of October, 1955 <sup>1</sup>[,] <sup>1</sup>[and after the first day of July, 1970, the Province of Baluchistan, comprising the territories mentioned in the Schedule to the Province of West Pakistan (Dissolution) Order, 1970:]

8[(7) “British India.” “British India” shall mean, as respects the period before the <sup>9</sup>commencement of Part III of the Government of India Act, 1935 (26 Geo.5.2.), all territories and places within His Majesty's dominions which were for the time being governed by His Majesty through the Governor General of India or through any Governor or officer subordinate to the Governor General of India, and as respects any period after that date <sup>10</sup>[and before the establishment of the Federation of Pakistan] means all territories for the time being comprised within the Governors' Provinces and the Chief Commissioners' Provinces, except that a reference to British India in an Indian law passed or made before the <sup>9</sup>commencement of Part III of the Government of India Act, 1935 (26 Geo.5.2.), shall not include a reference to Berar:]

(8) “British possession.” “British possession” shall mean any part of Her Majesty's dominions, exclusive of the United Kingdom, and, where parts of those dominions are under both a central and a local legislature, all parts under the Central Legislature shall, for the purposes of this definition, be deemed to be one British possession:

1[(8aa) “Central Act.” “Central Act” shall mean an Act of the Central legislature, and shall include, except in section 5, an Act made by the Governor General under section 67 B of the Government of India Act, <sup>2</sup>[ \* \* \* :]

3[(8ab) “Federal Government.” “<sup>4</sup>[Federal Government]” shall—

- (a) in relation to anything done before the <sup>5</sup>commencement of Part III of the Government of India Act, 1935 (26 Geo.5.2.), mean the Governor General in Council or the authority competent at the relevant date to exercise the functions corresponding to those subsequently exercised by the Governor General;
- (b) in relation to anything done after the <sup>5</sup>commencement of Part III of the said Act, but before the establishment of the Federation of Pakistan, mean, as respects matters with respect to which the Governor General was by or under the provisions of the said Act then in force required to act in his discretion, the Governor General and as respects other matters, the Governor General in Council; <sup>6</sup>[\*]

  - (i) in relation to functions entrusted under sub-section (1) of section 124 of the said Act to the Government of a Province, the Provincial Government acting within the scope of the authority given to it under that sub-section; and
  - (ii) in relation to the administration <sup>9</sup>[before the fourteenth day of October, 1955,] of a Chief Commissioner's Province, the Chief Commissioner acting within the scope of the authority given to him under sub section (3) of section 94 of the said Act <sup>10</sup>[;] <sup>11</sup> \*

(17) **“Enactment.”** “enactment” shall include a Regulation (as hereinafter defined) and any Regulation of the Bengal, <sup>1</sup>[\*] or Bombay Code, and shall also include any provision contained in any Act or in any such Regulation as aforesaid:

(18) **“Father.”** “father “, in the case of anyone whose- personal law permits adoption, shall include an adoptive father:

- (b) as respects any period after the establishment of the Federation of Pakistan all territories for the time being included in the Dominion of India <sup>9</sup>[or the Union of India:]

(28) **“Local authority.”** “local authority” shall mean a municipal committee, district board, body of port commissioners or other authority legally entitled to, or entrusted by the Government with, the control or management of a municipal or local fund:

(31) **“Magistrate.”** “Magistrate” shall include every person exercising all or any of the powers of a Magistrate under the Code of Criminal Procedure for the time being in force:

## GENERAL RULES OF CONSTRUCTION

5. Coming into operation of enactments.—<sup>1</sup>[(1) Where any Central Act is not expressed to come into operation on any particular day, then it shall come into operation on the day on which it receives the assent, —

- (a) in the case of a Central Act made before the twenty-third day of March, 1956, of the Governor-General, and
- (b) in the case of a Central Act made after that date, of the President.]

(3) Unless the contrary is expressed, a <sup>3</sup>[Central Act] or Regulation shall be construed as coming into operation immediately on the expiration of the day preceding its commencement.

6. Effect of repeal. Where this Act, or any <sup>2</sup>[Central Act] or Regulation made after the commencement of this Act, repeals any enactment hitherto made or hereafter to be made, then, unless a different intention appears, the repeal shall not—

- (a) revive anything not in force or existing at the time at which the repeal takes effect; or
- (b) affect the previous operation of any enactment so repealed or anything duly done or suffered thereunder; or
- (c) affect any right, privilege, obligation or liability acquired, accrued or incurred under any enactment so repealed; or
- (d) affect any penalty, forfeiture or punishment incurred in respect of any offence committed against any enactment so repealed; or
- (e) affect any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid;

and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such penalty, forfeiture or punishment may be imposed as if the repealing Act or Regulation had not been passed.

**10. Computation of time.**<sup>1</sup> (1) Where, by any <sup>3</sup>[Central Act] or Regulation made after the commencement of this Act, any act or proceeding is directed or allowed to be done or taken in any Court or office on a certain day or within a prescribed period, then, if the Court or office is closed on that day or the last day of the prescribed period, the act or proceeding shall be considered as done or taken in due time if it is done or taken on the next day afterwards on which the Court or office is open:

Provided that nothing in this section shall apply to any act or proceeding to which the <sup>1</sup>[Limitation Act, 1908] (IX of 1908), applies.

(2) This section applies also to all <sup>4</sup> [Central Acts] and Regulations made on or after the fourteenth day of January, 1887.

**<sup>2</sup>11. Measurement of distances.** In the measurement of any distance, for the purposes of any <sup>3</sup>[Central Act] or Regulation made after the commencement of this Act, that distance shall, unless a different intention appears, be measured in a straight line on a horizontal plane.

**12. Duty to be taken prorata in enactments.** Where, by any enactment now in force or hereafter to be in force, any duty of customs or excise, or in the nature thereof, is leviable on any given quantity, by weight, measure or value of any goods or merchandize, then a like duty is leviable according to the same rate on any greater or less quantity.

**13. Gender and number.** In all <sup>4</sup>[Central Acts] and Regulations, unless there is anything repugnant in the subject or context, —

- (1) words importing the masculine gender shall be taken to include females; and
- (2) words in the singular shall include the plural, and *vice versa*.

## POWERS AND FUNCTIONARIES

**14. Powers conferred to be exercisable from time to time.** — (1) Where, by any <sup>6</sup>[Central Act] or Regulation made after the commencement of this Act, any power is conferred <sup>7</sup>\* \* \*, then, <sup>8</sup> [ unless a different intention appears], that power may be exercised from time to time as occasion requires.

(2) This section applies also to all <sup>9</sup> [Central Acts] and Regulations made on or after the fourteenth day of January, 1887.

**15. Power to appoint to include power to appoint ex officio.** Where, by any <sup>3</sup>[Central Act] or Regulation, a power to appoint any person to fill any office or execute any function is conferred, then, unless it is otherwise expressly provided, any such appointment, if it is made after the commencement of this Act, may be made either by name or by virtue of office.

**16. Power to appoint to include power to suspend or dismiss.** Where, by any <sup>3</sup>[Central Act] or Regulation, a power to make any appointment is conferred, then, unless a different intention appears, the authority having <sup>1</sup>[for the time being] power to make the appointment shall also have power to suspend or dismiss any person appointed <sup>2</sup>[whether by itself or any other authority] in exercise of that power.

**17. Substitution of functionaries.**— (1) In any <sup>3</sup>[Central Act] or Regulation made after the commencement of this Act, it shall be sufficient, for the purpose of indicating the application of a law to every person or number of persons for the time being executing the functions of an office, to mention the official title of the officer at present executing the functions, or that of the officer by whom the functions are commonly executed. .

(2) This section applies also to all <sup>3</sup>[Central Acts] made after the third day of January, 1868, and to all Regulations made on or after the fourteenth day of January, 1887.

**18. Successors.** — (1) In any <sup>3</sup>[Central Act] or Regulation made after the commencement of this Act, it shall be sufficient, for the purpose of indicating the relation of a law to the successors of any functionaries or of corporations having perpetual succession, to express its relation to the functionaries or corporations.

(2) This section applies also to all <sup>3</sup>[Central Acts] made after the third day of January, 1868, and to all Regulations made on or after the fourteenth day of January, 1887.

**19. Official chiefs and subordinates.** — (1) In any <sup>3</sup>[Central Act] or Regulation made after the commencement of this Act, it shall be sufficient, for the purpose of expressing that a law relative to the chief or superior of an office shall apply to the deputies or subordinates lawfully performing the duties of that office in the place of their superior, to prescribe the duty of the superior.

(2) This section applies also to all <sup>3</sup>[Central Acts] made after the third day of January, 1868, and to all Regulations made on or after the fourteenth day of January, 1887.

## PROVISIONS AS TO ORDERS, RULES, ETC., MADE UNDER ENACTMENTS.

<sup>1</sup>20. Construction of orders, etc., issued under enactments. Where, by any <sup>9</sup>[Central Act] or Regulation, a power to issue any <sup>2</sup>[notification], order, scheme, rule, form or bye-law is conferred, then expressions used in the <sup>2</sup>[notification], order, scheme, rule, form or bye-law, if it is made after the commencement of this Act, shall, unless there is anything repugnant in the subject or context, have the same respective meanings as in the Act or Regulation conferring the power.

Where, by any <sup>9</sup>[Central Act] or Regulation which is not to come into force immediately on the passing thereof, a power is conferred to make rules or bye-laws, or to issue orders with respect to the application of the Act or Regulation, or with respect to the establishment of any Court or office or the appointment of any Judge or officer thereunder, or with respect to the person by whom, or the time when, or the place where, or the manner in which, or the fees for which, anything is to be done under the Act or Regulation, then that power may be exercised at any time after the passing of the Act or Regulation; but rules, bye-laws or orders so made or issued shall not take effect till the commencement of the Act or Regulation.

**23. Provisions applicable to making of rules or bye-laws after previous publication.** Where, by any <sup>10</sup>[Central Act] or Regulation, a power to make rules or bye-laws is expressed to be given subject to the condition of the rules or bye-laws being made after previous publication, then the following provisions shall apply, namely: —

(1) the authority having power to make the rules or bye-laws shall, before making them, publish a draft of the proposed rules or bye-laws for the information of persons likely to be affected thereby;

(2) the publication shall be made in such manner as that authority deems to be sufficient, or, if the condition with respect to previous publication so requires, in such manner as the <sup>1</sup>[Federal Government] or the <sup>2</sup>[ Provincial Government] prescribes;

(3) there shall be published with the draft a notice specifying a date on or after which the draft will be taken into consideration;

(4) the authority having power to make the rules or bye-laws, and, where the rules or bye-laws are to be made with the sanction, approval or concurrence of another authority, that authority also, shall consider any objection or suggestion which may be received by the authority having power to make the rules or bye -laws from any person with respect to the draft before the date so specified;

(5) the publication in the <sup>3</sup>[official Gazette] of a rule or bye-law purporting to have been made in exercise of a power to make rules or bye-laws after previous publication shall be conclusive proof that the rule or bye-law has been duly made.

**24. Continuation, of orders, etc., issued under enactments repealed and re-enacted.** Where any <sup>5</sup>[Central Act] or Regulation is, after the commencement of this Act, repealed and re-enacted with or without modification, then, unless it is otherwise expressly provided, any <sup>4</sup>[ appointment, notification], order, scheme, rule, form or bye-law <sup>4</sup>[ made or] issued under the repealed Act or Regulation, shall, so far as it is not inconsistent with the provisions re -enacted, continue in force, and be deemed to have been <sup>4</sup>[made or] issued under the provisions so re- enacted, unless and until it is superseded by any <sup>4</sup>[appointment, notification], order, scheme, rule, form or bye-law <sup>4</sup>[made or] issued under the provisions so re-enacted <sup>6</sup>[and when any <sup>7</sup>[Central Act) or Regulation, which, by a notification under <sup>8</sup>[ any law], has been extended to any local area, has, by a subsequent notification, been withdrawn from and re-extended to such area or any part thereof, the provisions of such Act or Regulation shall be deemed to have been repealed and re- enacted in such area or part within the meaning of this section ].

(2) The authority, office or person making any order or issuing any direction under the powers conferred by or under any enactment shall, so far as necessary or appropriate, give reasons for making the order or, as the case may be, for issuing the direction and shall provide a copy of the order or as the case may be, the direction to the person affected prejudicially.]

## MISCELLANEOUS

**25. Recovery of fines.** Sections 63 to 70 of the Pakistan Penal Code and the <sup>1</sup>provisions of the Code of Criminal Procedure for the time being in force in relation to the issue and the execution of warrants for the levy of fines shall apply to all fines imposed under any Act Regulation, rule or bye-law unless the Act, Regulation, rule or bye-law contains an express provision to the contrary.

**26. Provision as to offences punishable under two or more enactments.** —Where an act or omission constitutes an offence under two or more enactments, then the offender shall be liable to be prosecuted and punished under either or any of those enactments, but shall not be liable to be punished twice for the same offence.

**<sup>2</sup>27. Meaning of service by post.** —Where any <sup>5</sup>[Central Act] or Regulation made after the commencement of this Act authorizes or requires any document to be served by post, whether the expression “serve” or either of the expressions “give” or “send” or any other expression is used, then, unless a different intention appears, the service shall be deemed to be effected by properly addressing, pre-paying and posting by registered post, a letter containing the document, and, unless the contrary is proved, to have been effected at the time at which the letter would be delivered in the ordinary course of post.

**<sup>3</sup>28. Citation of enactments.**— (1) In any <sup>5</sup>[Central Act] or Regulation, and in any rule, bye-law, instrument or document, made under, or with reference to, any such Act or Regulation, any enactment may be cited by reference to the title or short title (if any) conferred thereon or by reference to the number and year thereof, and any provision in an enactment may be cited by reference to the section or sub-section of the enactment in which the provision is contained.

(2) In this Act and in any <sup>5</sup>[Central Act] or Regulation made after the commencement of this Act, a description or citation of a portion of another enactment shall, unless a different intention appears, be construed as including the word, section or other part mentioned or referred to as forming the beginning and as forming the end of the portion comprised in the description or citation.

**<sup>5</sup>29. Saving for previous enactments, rules and bye-laws.** The provisions of this Act respecting the construction of Acts, Regulations, rules or bye-laws made after the commencement of this Act shall not affect the construction of any Act, Regulation, rule or bye-law made before the commencement of this Act, although the Act, Regulation, rule or bye-law is continued or amended by an Act, Regulation, rule or bye-law made after the commencement of this Act.

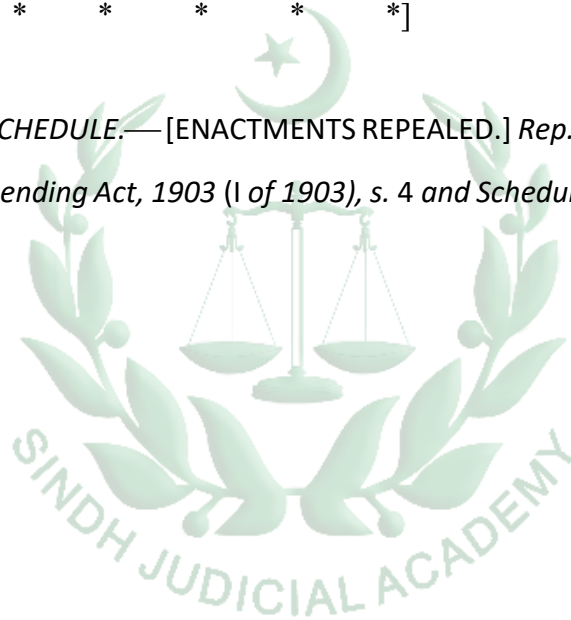
