# TWO-WEEK BAR VOCATIONAL COURSE FOR LAW GRADUATES (BATCH-12) FROM 08 – 20 JANUARY 2024 AT HYDERABAD



## **Background Context**

The Bar Vocational Course was meticulously crafted to elevate the skills, standards, and overall quality of law graduates, aligning with the esteemed order dated 28-08-2018 in constitution petition No.134/2012 and civil Misc. Application No.1864/2010 in constitution petition No.09/2005. Subsequent orders on 06-06-2022 and 14-09-2022 by the Hon'ble Supreme Court of Pakistan in CMA No 61810/2020 in CP.NO 134/ 2012 further underscored the need for such enhancement.

In response to the directive, the Sindh Bar Council, through a letter dated 13-10-2022, approached the Sindh Judicial Academy to administer a "Two Weeks Bar Vocational Course." This course is an integral part of the mandatory six-month training/pupillage period, a prerequisite for law graduates aspiring to join the legal profession and practice law.

With due consideration to the observations of the Hon'ble Supreme Court of Pakistan, the academy specifically tailored a "Two-week training program" for young law graduates. The program focuses on fortifying their capacity to draft pleadings related to procedural and special laws. The training delves into the academic intricacies of drafting and the step-by-step trial process in courts for judicial appreciation. Additionally, it incorporates detailed case law studies on frequently encountered issues in courtrooms.

The training program was strategically designed to mirror the progression of a trial. Numerous cases are included, spanning various issues, wherein discussions on pleadings and different applications supported by

affidavits aim to provide comprehensive insights into the types of cases commonly filed in courts. The primary objective of this training is to instill an analytical approach in trainees for effective problem-solving in legal cases.

Contrary to encouraging rote memorization of legal provisions, the academy emphasizes enhancing the trainees' comprehension to tackle complex situations that may arise in court proceedings. Recognizing that law, especially procedural law is a dynamic subject in the realm of social science, the academy fosters an environment where trainees respect each other's perspectives, fostering a holistic understanding of the subject matter.

In this regard, the SJA has already conducted 12 Batches in the year 2023.

#### <u>Brief Introduction to Training</u>

In the context above, a Two-Week Bar Vocational Course for Law Graduates on procedural laws was arranged from 08 - 20 January 2024 (Batch-12) at Mumtaz Mirza Auditorium, Hyderabad. In this interactive/practical training program, a total of 460 Law Graduates participated.
